

## **DANCING FOR JOY, LLC COVID-19 WAIVER**

### **Hold Harmless, Assumption of own Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies have made certain recommendations on social distancing and have, in many locations, prohibited the congregation of groups of people. These recommendations are changing along with the state of the pandemic.

Dancing For Joy (DFJ) has put in place preventative measures, and is staying current with following the recommendations by the state health agencies, to reduce the spread of COVID-19; however, DFJ cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending DFJ could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and/or myself may be exposed to or infected by COVID-19 by attending DFJ and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I understand that the risk of becoming exposed to or infected by COVID-19 at DFJ may result from the actions, omissions, or negligence of myself and others, including, but not limited to, DFJ employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at DFJ or participation in DFJ classes. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless DFJ, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of DFJ, its employees, agents, representatives, and participants; whether a COVID-19 infection occurs before, during, or in conjunction with any DFJ program, class or event.
